
IDRC Privacy Agreement

This notice explains how a change in IDRC service providers will impact the privacy of applicants to IDRC calls for proposals.

FluidReview, IDRC's regular service provider, based in Canada and providing the platform for applications for IDRC funding, has been purchased by SurveyMonkey, another service provider based outside of Canada. IDRC's association with FluidReview and SurveyMonkey is now subject to the following Terms of Use and Privacy Policies:

As per the Terms of Use and Privacy Policies, data disclosed to FluidReview may be transmitted outside of Canada to other jurisdictions, including to Europe and the United States. Data transmitted to other jurisdictions will be subject to the laws of those jurisdictions. Data transmitted to the United States will be subject to the laws of the United States.

Data that is disclosed to FluidReview may include, but is not limited to, information contained in proposal package and the IP address of the computer from which a proposal package is submitted.

IDRC may make your information available to related parties, including technical experts or donors, for the purpose of assessing your proposal package. While your proposal package is being assessed, your information may remain on the FluidReview servers.


IDRC will make every effort to confirm that the information contained in your proposal package is deleted from FluidReview servers after IDRC has archived this information and moved it to IDRC servers. IDRC cannot, however, guarantee that this information will not remain on FluidReview servers or that the information has not been viewed or seized by third parties prior to its deletion.

Submitting your application under this call for proposals: Constitutes acknowledgement and acceptance of the potential transmission of data outside of Canada to other jurisdictions; Constitutes consent for sharing your information with related parties for the purpose of assessing your proposal package, as described herein; Constitutes consent for your information to be kept on FluidReview servers, wherever located, and consent for your information to be treated in accordance with FluidReview and SurveyMonkey's Terms of Use and Privacy Policies and in accordance with this notice.
